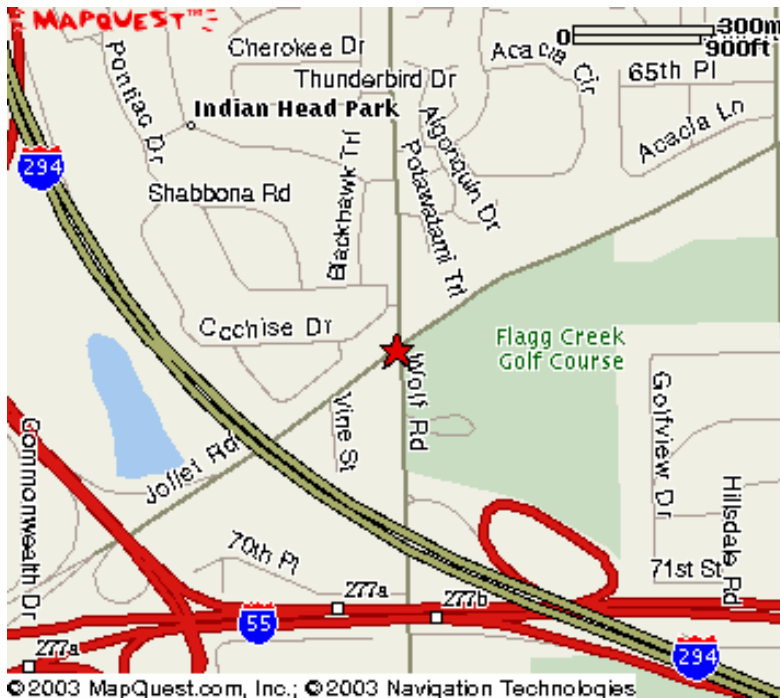

### **Western Irish Setter Club Judges Selection Policy**

Nominations for specialty show judges for 2008 (obedience, sweepstakes & conformation) will be accepted from January 1<sup>st</sup> 2007 until the nominations close at the general meeting January 17<sup>th</sup> 2007. Nominations may be made in person at the general meeting or by mail. Nominations made by mail should be sent in advance to the designated person. Envelopes shall be marked "**Judges Nomination**" on the outside and will be only accepted from full members, dues paid in full. All nominations must be accompanied by a brief biography of the nominee and a reason for their nomination. Nominations without the required information will not be accepted. No additional nominations will be accepted after the January general meeting. Nominations will be published in the February newsletter.

Voting on the nominated judges will take place at the February meeting. Only full members in good standing (dues paid) may vote. Votes may be accepted by mail if the member cannot attend the meeting. Mail votes should be sent in enough time to reach the same designated person before the February meeting and must be marked Judges Vote boldly on the outside and will remain sealed until the February meeting. Members may vote for two nominated judges in each category: obedience, sweepstakes and conformation.
